Although the charity's origins were founded in the care of orphaned and abandoned children, today we maintain over 40 different projects and services for the young and old, the vulnerable and needy in society.

Our remit is to help people who are disadvantaged by physical or social factors and who often find it difficult to access appropriate support or services geared towards their particular requirements. St Cuthberts Care's role encompasses help for children with special needs, short break respite provision, fostering services, therapeutic work with families and care for older people.
